The regular monthly meeting of the Big Flat City Council was held March 21 due to severe storm warnings for the are during the hours on March 14.

Clint & Jerry Maxwell have purchased the Big Flat Tire & Auto from D.J. & Brittany Johnson & are wanting to have the lease placed in their names. Had been given a copy of lease & stated they did not want to make any changes. Council approved the lease to be placed in the names of Clint & Jerry Maxwell. Lease in their names will be available for their signatures.

Minutes & Bank Reconciliations for General Fund, Building Fund, Street Fund, & Fire Fund were read. ARPA & Community Center Renovation Funds unchanged.

Water Dept. Report: Electric motor installed in Emergency Pump House & working. Lines were flushed. Water clear of air w/leak in chlorinator line repaired. Rich & Glenda met with Chris Harris from AR. Rural Water Assn. re Rate Study. Next month will have ordinances to consider & pass re increase in water rates & revenue bonds.

Fire Dept Report: Three (3) runs. Motion to acknowledge payment to Overhead Door Co. in amount of \$815.63 by Ck # 2010 for repair of Door #1 in FH #1 due & payable by February 26, 2024 by Kim, 2nd by Sharon. All Voted – Passed.

Motion by Shawn, 2nd by Lonnie to accept the Minutes & Reports as read. All Voted - passed

Motion by Shawn, 2nd by Lonnie to contract with Charles Hafner for 2024 to mow City Part at rate of \$275/job at his discretion of need & to do Weed Eating of City Property at the rate of \$375.00/job for 6 times after which would need Council approval for more times. All Voted – passed

Motion by Lonnie, 2nd by Bonnie to Contract with Charles Hafner to install the following in OLR Bathroom: Fixtures, Drain line placement including labor at a cost of \$2,640.00. In addition at a cost of \$2,200.00 to weatherproof the outside of bathroom to include: concrete blocks for footings, treated lumber & foiled back foam insulation for underpinning, finishing the side walls & underpinning with white metal siding for a total cost of \$4,840.00.

Glenda reported that Ernestine McDaniel, Mayor of Fifty-Six has again suggested a meeting between the cities during the Fifty-Six Council Meeting on March 18. Explained that I was not available on that evening and would get with Big Flat Council for a suitable date. Council requested that Rich Hiter, Mike Treat, & Glenda go as could not depend that everyone would be available on a given evening. The three agreed & Glenda will let her know on Friday.

Homecoming: Kim reported that vendors would again be offered space at the same fee as last year.

The old/used tires are being removed from the Big Flat Tire & Auto property.
